To my fellow Retirees, Terminated Vested Participants and Beneficiaries:

About three months ago you should have received a letter from me about my role as the Retiree Representative for the Automotive Industries Pension Fund (Fund). I was appointed by the Board of Trustees to serve as the Retiree Representative under the Multiemployer Pension Reform Act of 2014 (MPRA).

The Trustees voted to submit an application to reduce benefits. The application was submitted to the Treasury Department on September 27, 2016. About one month ago you should have received a packet of information from the Fund, informing you of the suspension application and telling you how much your benefit would be reduced if Treasury approves the Fund's application.

One of the roles I have as the Retiree Representative is to communicate with all of you and to listen to your concerns and comments about this process and to forward that information to the Trustees.

As part of the communication process, the Fund is sponsoring 4 separate meetings to give you an opportunity to express your concerns and to ask questions. Those meetings will be held as follows:
